MEMBERSHIP CLASSIFICATIONS – OHIO CHAPTER ISA

REGULAR

Individuals actively engaged in arboriculture who reside in Ohio and are a member of ISA International; may vote and hold office.

AFFILIATE

Individuals who reside outside of Ohio and may or may not be a member of ISA International; may vote but not hold office.

CHAPTER ONLY

Individuals actively engaged in arboriculture who reside in Ohio but are not a member of ISA International; may vote and hold office.

LIFE

Individuals who desire to make a one-time contribution of \$1,000.00; may vote, but not hold office.

SENIOR

Members who are in good standing for at least ten consecutive preceding years, are retired, and who indicate in writing the desire for an inactive status; may not vote nor hold office.

STUDENT

Students enrolled in an accredited secondary or post-secondary educational institution; may not vote nor hold office. Must send copy of current student ID card.

SUSTAINING

Commercial firms, organizations, or individuals desiring to promote the purpose and welfare of Ohio Chapter ISA and making a contribution of \$250.00 or more annually; may not vote nor hold office.
